# UVU Executive Education Essential Oils Certificate Policies and Procedures

#### Attendance

UVU Executive Education will be offering two essential oil certifications: the **Essential Oils Advocate Certificate** and the **Advanced Essential Oils Advocate Certificate**. Each certificate is composed of 3 Courses. Each Course is hosted online and self-paced. Participants will be given 3 months to complete each Course. Participants will not be required to attend an in-person class to receive the certificate. Participants must receive an 80% on the final exam to be able to pass a Course.

## **Payment**

Individual payments will be made through the online registration system of UVU. Organizations who would like to pay for access in bulk for their participants may request for an invoice from UVU. Any arrangement varying from this practice must be approved by UVU Executive Education. Full payment must be received by UVU prior to the start of the Course which the participant would like to attend. Refunds will not be given for a course that has been opened. If a refund is requested for a course purchased in a package only the course being refunded needs not have been started. Additional courses in the package will be charged at their original prices and not at the package discount rate.

#### **Cancellations**

Cancellation requests must be made 7 days prior to the Course start date to receive a refund. Course reimbursement will be for the full amount minus a 10% non-refundable processing fee.

If canceling less than 7 days prior to the Course start date, or you do not attend, you will forfeit the entire payment.

We reserve the right to cancel any course for insufficient enrollment or other conflicts that may arise.

Those who fail to complete all requirements within the three-year period will lose credit for all previously completed work.
